4. Finance : Trevor read out the E Mail that Peter had circulated, the 3 main

items being, cash in the bank accounts amounting to £75k+, the anonymous sponsor donation via the Charity Aid Foundation was still awaited as is the SADC contribution from Cllr Rowland's

locality budget pot.

Zanna suggested part be used to advertise at and with "Larks in

the Park"

Val suggested vouchers given to returning users to new premises that would be offset against their future rents.

Cathie suggested the provision of BBQ equipment for 'Larks in the Park' as these tend to be good money raisers at events

5. Managers Report: Cathie expanded upon her report, Ad Hoc bookings of 17No.

to date, compares favourably to numbers pre Covid, i.e.2020, having been to see the Portakabins, temporary replacements rooms mainly for childrens groups but could easily house other users, these were fantastic, better than imagined, quiz night is on her agenda to organize, Larks in the Park is moving along nicely, Cathie commented that not only do we need to encourage users to return but mayhap have a stall at the event advertising themselves with any proceeds going towards FCC's new build "extras" that will be needed, on Friday 12th March there is a Fish and Chip

lunch, book your place.

6. Update:

David appraised the meeting of various discussions held with Jay Pattni, SADC, mainly the storage of current equipment which would be best housed in a container, this could be the one situated alongside the portakabins providing there was easy access. Trevor asked re finance, was this dependant upon fitting out of new build as to what contribution would be required from FCC? A detailed specification is needed from SADC, ask them at meeting on 29th this month so it can be discussed by all, especially hirers as their input thoughts, ideas etc. ought be included in decisions made.

7 New Build:

Trevor having written to Jay Pattni predominately on who was taking responsibility for the presentation to the public, after asking what had gone on before and being supplied with all relevant information by Mike Neighbour, Jay stated it was the responsibility of SADC who would inform all local residents and retailers(shops).

Josie suggested a polite note mainly to Royal Road residents, but also to Burham Road, especially close to linking passageway, informing them of FCC involvement and what to expect during the rebuild, Josie offered to draft this letter identifying there was no come back on FCC.

Vicky suggested we increase the distribution of notification say to a mile radius of centre, posts on facebook would be more effective, it is easily amended, but this only after planning fully approved, which could be late April early May.

Public relations are a priority and there is a need to keep them fully informed.

Trevor asked Josie to propose to council a rent free period.
